2.	No physical contact between persons from different households/bubbles, unless there is an emergency.		Leaders

4.	A system of flow through building to avoid pinch points. (Parents to be told in advance and at the end of the service how to drop off/pick up their children)		AR/ Service leader	Parents enter and exit the building through main entrance. Pick up/drop off done at outer side doors.
5.	Children to remain in consistent 'bubbles' of 15 children.		AR/leaders	
6.	Children to stay in their group rooms and avoid mixing with other groups/main congregation.		Leaders	
7.	Social distancing encouraged in children's groups.		Leaders	
8.	Seating arrangements and activities adapted for social distancing.		Leaders	
9.	No singing/raised voices during sessions.		Leaders	
10.	Children encouraged to 'catch it, bin it, kill it' to ensure good respiratory hygiene.		Leaders

Doors kept open where possible to reduce contact with door handles (may not be appropriate for fire safety, to maintain suitable temperature or noise disruption)		AR/leaders	Lounge – side door open (with chair in front), some windows open (where safe). Lower hall – fire door and door into corridor open (with guards in place), windows open
2.	Cleaning of surfaces likely to be touched regularly with appropriate sanitiser wipes, including those at child height, both before and after sessions.		After session: Leaders	
3.	Items/furniture not in use to be covered, where possible			Eg. table football table, play house, sofas
4.	No serving of drinks, children encouraged to bring a water bottle. Children to be served a biscuit with tongs (after first sanitising their hands).		Parents/leaders	
5.	No distribution of Bibles or other books.		Leaders	
6.	No shared equipment (outside of households) in JC groups. If doing a craft activity, each child to have their own set of resources/equipment.		Leaders

1.	Parents encouraged to ask children to use the toilet at home before they come.		Parents	
2.	Children to use the toilet allocated to their group. One child to be in the bathroom at a time.		Leaders	Scramblers/Explorers: Ladies toilet Adventurers: Disabled toilet
3.	If children need to use the toilet, they should be accompanied to the corridor by the Junior Church helper and supervised in hand washing.		Leaders	
4.	Junior Church leaders to wipe down touch points afterwards (flush, lock and tap)		Leader supervising toilet trip	
5.	Parents who need to change a nappy are asked to take all waste home with them and clean area after use.		Parents
